NOTES Current interest rates are displayed in our offices and on the Society's website. If you are a basic rate taxpayer, since 6 April 2016 you have had a £1,000 Personal Savings Allowance (£500 if you are a higher rate taxpayer). *Gross Rate the contractual rate of interest to be paid on a savings account without any deduction being made in respect of personal Income Tax liability. ****AER** stands for Annual Equivalent Rate and illustrates what the interest rate would be if interest was paid and compounded once each year (or monthly as the case may be). *****Tax Free Savings** Contractual rate of interest payable when the interest is exempt from tax.
