NOTES Current interest rates are displayed in our offices and on the Society's website. \*Gross Rate the contractual rate of interest to be paid on a savings account without any deduction being made in respect of personal Income Tax liability. \*\*AER stands for Annual Equivalent Rate and illustrates what the interest rate would be if interest was paid and compounded once each year (or monthly as the case may be). \*\*\*Tax Free Savings Contractual rate of interest payable when the interest is exempt from tax.
